If You Withdraw Before Approval. You and any co-applicants may not withdrawyour Application or the application deposit. If before signing the Lease Contract, you or any co-applicant withdraws an Application or notifies us that you've changed your mind about renting the dwelling unit, we'll be entitled to retain all Lease Information above.
